What to Look For by Chuck Tague, Nature Observer News

Phenologic perspective: September 8 through September 29, 2001

Keep an eye out for migrating songbirds – the last waves of migrating warblers will be passing through by the end of the month. Toward the end of the month look for Yellow-rumped Warblers, kinglets and flocks of sparrows. Look for grosbeaks, Scarlet Tanagers in their spotty yellow plumage, cuckoos, flycatchers and vireos. In the evening the flocks of American Robins, blackbirds and European Starlings will increase. When will the Broad-winged Hawks peak at the Allegheny Front Hawk Watch? Some of the hawkwatchers think the good numbers in the first week of September might indicate an early flight. The count will get higher for the next two weeks. In Pennsylvania the peak is usually near the third week of September. Hope for east winds during the peak. Osprey, Bald Eagles, Northern Harriers and American Kestrels also pass through in good numbers in September. As the month ends, watch for an increase in the number of Sharp-shinned Hawks and Cooper's Hawks.

County Parks, please help

I am writing to you because I'm worried about our county parks. I hope you can help.

County Executive Rich Fitzgerald is in private negotiations to drill for Marcellus Shale in Allegheny County parks. Deer Lakes Park is already under negotiation. Round Hill and Settlers Cabin Parks have been mentioned as well.

To calm fears Fitzgerald told the papers he wouldn't give up surface rights and therefore North and South Parks would be harder to drill. However, there are no guarantees. To get at the gas, new industrial activity has to happen at the parks' borders and new pipelines would cross them. <http://www.post-gazette.com/stories/local/region/allegheny-county-considers-drilling-beneath-parks-691481/>

My County Council representative, Barbara Daly Danko, feels things are happening too fast. Referring to the already-approved airport drilling deal (on industrial land) she said, "The parks are different" (not industrial) and has proposed a 3-year moratorium on drilling them. This is a pause to allow time for legal and environmental issues to shake out, not a ban. <http://www.post-gazette.com/stories/local/region/allegheny-county-councilwoman-danko-proposes-3-year-hold-on-drilling-in-parks-702254/#ixzz2fOhc6tlw>

Danko has said that she's getting a lot of support from her constituents but if this proposal is to pass it must have the votes of suburban Council reps as well. That's where you come in.

If you think it's a good idea to pause before rushing in to drill our county parks, please do the following:

2. Tell them "Support Barbara Daly Danko's moratorium on drilling the county parks."
3. Tell them what County parks you use. If you feel like it, describe why you like those parks (example: birding in Harrison Hills Park).
4. Sign with your Name and Address or Township (this shows county-wide concern).
5. Also email Rich Fitzgerald at executive@alleghenycounty.us with your name, address and the message "I support Danko's moratorium" or "Don't drill the County Parks." You don't need to make this burdensome by including anything else in your message.

Here are reasons why it's good to wait to drill our parks ... or not drill them at all.
